## **GOOD OF THE CLUB:**

Anita Peterson gave the following speech:

For many years, the club has held monthly club meetings which were very enjoyable to attend and members could freely contribute ideas and opinions. Over the past year, many club members have commented that it has become increasingly disturbing that the monthly club meetings have been used by a select few people to be very confrontational and accusatory with no regard for other member's ideas or opinions. This reoccurring confrontational attitude at the meetings has caused many members to be uncomfortable about attending and participating, and has resulted in some new members never returning after their first unpleasant club business meeting. It has been noted that e-mails have also been used to create unnecessary confrontation and controversy. This has got to stop for the good of the future club morale. Club members deserve to be treated with dignity and respect at all times.

## **COMMITTEE REPORTS:**

1. Finance Committee - Frank Piotrkowski reported that the Finance Committee will meet with an investment advisor from Wells Fargo on January 21, 2012. (See that attached report on the History of Club Funds).

**2. History of NMRC Club Funds** – The following e-mail of the History of NMRC Club Funds was referenced at the meeting:

There are many new club members who do not know how the Nauset Model Railroad Club earned the funds we now have in our club accounts and it is important that this information be shared.

Originally, the club was significantly smaller (approximately 10-15 members) and club members traveled around to each other's homes for the monthly business meetings, and later met in the Orleans Methodist Church. Through the years, club members moved layouts from place to place at the Christmas holidays to set up displays, but lacked space and funding since at that time membership dues were \$1.00 for life.

Our current club President, Roy Jones was able to coordinate a deal with Safety Insurance where, as a "Supporting" club member, many people could contribute \$5.00 annually to our club and receive a significant discount on their automobile insurance. It was a lot of time-consuming, hard work by a team made up of Roy Jones, Warren Peterson and Karen Sharpless every month creating and coordinating an extremely large Access computer database (approximately 15,000 people), typing up 1,200± monthly bills, stuffing and sealing envelopes, mailing them, and then keeping track of (and reporting to the insurance company) the number of "Supporting" membership dues that were returned to us by mail for approximately 4 years. Some of our visitors today still mention that they were once members of our club through the insurance discount program.

Not everyone responded to the billings, but enough people appreciated getting the automobile discount enough to be willing to contribute the \$5.00 club membership dues annually to be a "Supporting" member of our train club. This resulted in the \$20,000 we had in our account when we moved into the current Train Room in January 2005, anticipating that we would only be able to stay at the Train Room for 4 years, and then we would run out of funds.

Because of the initial amount of money we received from the "Supporting" insurance discount club members, donations we have received from Train Room visitors over the past 7 years, and judicious planning by our Treasurers and Finance Committee, we have been fortunate enough to be able to remain at the Train Room for the foreseeable future.
